# ACADEMIC SYSTEM AND APPROACH

BALLB at GSL under Purbanchal University incorporates a set of multiple approaches, skills and standard operating procedures to be complied with over the scheme of a five-year course of study and apprenticed learning of the legal profession. The key procedures for making the program a robust course is outlined herewith:



## Specialization

Students may choose elective courses based on their interests and career goals (e.g., Business Law, Criminal Law, Environmental Law etc.).



## Internship

Students will be required to complete internships typically with law firms, courts, government bodies, NGOs or Corporate Sectors.

### Lectures & Seminars

As a core part of the course deliverance, lectures in BALLB will be delivered by experienced faculty members, often supplemented with guest lectures from industry experts, judges and practitioners.



### Presentations

Presentations are the integral courses of classroom deliveries in BALLB at GSL. Students are assigned term paper covering diverse subjects from the first year of study commencement. Subject faculties bear an autonomy to select numerous agendas and issues of academic and career significance that the students in group and on individual basis are entitled to complete. Completed term papers are defended by students in group as well as individually with the formal presentations evaluated by expert faculties and juries.



### Case Studies

Learning from cases is our primary approach to legal education. At GSL, case studies will be prioritized with an emphasis on analyzing real-life cases to understand the practical application of legal principles.



### Interactive Learning

Students will be encouraged to participate in group discussions, presentations and role-playing exercises to foster critical thinking and effective communication.



### Moot Court

Moot courts and mock trials form an essential part of BALLB program at GSL, helping students practice advocacy, legal research and writing.



### Legal Aid Clinics

The University may offer legal aid clinics where students can assist underprivileged communities with legal issues and provide an opportunity to contribute to society.



### Law Clinic

The Global School of Law (GSL) runs fully supervised Law Clinics led by practicing lawyers to provide students with practical legal training. These clinics offer hands-on experience through real case involvement, enhancing students' legal reasoning, advocacy, and problem-solving skills. GSL also organizes events to simulate real legal environments and provides free legal aid to marginalized communities, promoting social responsibility. Students participate in tasks like file studies, case drafting, and court simulations, supported by legal research and presentations. The clinics aim to bridge the gap between theory and practice, fostering a well-rounded legal education.



### Outreach Visits and Exposures

GSL engages the students with outreach visits organized annually on learning from hands-on-experience with the exposure of real legal sector practices. Students are ensured an opportunity to visit courts, prisons and enterprises for an interaction, review and observation of legal frameworks the concerned forums are operated with. The visits are used to make projects on legal studies and student participated in the visits have to present the findings in formal set up after completion of outreach programs.

He later served in various capacities within the judiciary, including Judicial Officer (2047–2053 B.S.), Under Secretary (2053–2063), District Judge (2063–2073), and High Court Judge (2073–2081). He currently serves as a faculty member at Global School of Law, where he brings his judicial insight and academic expertise into the classroom.

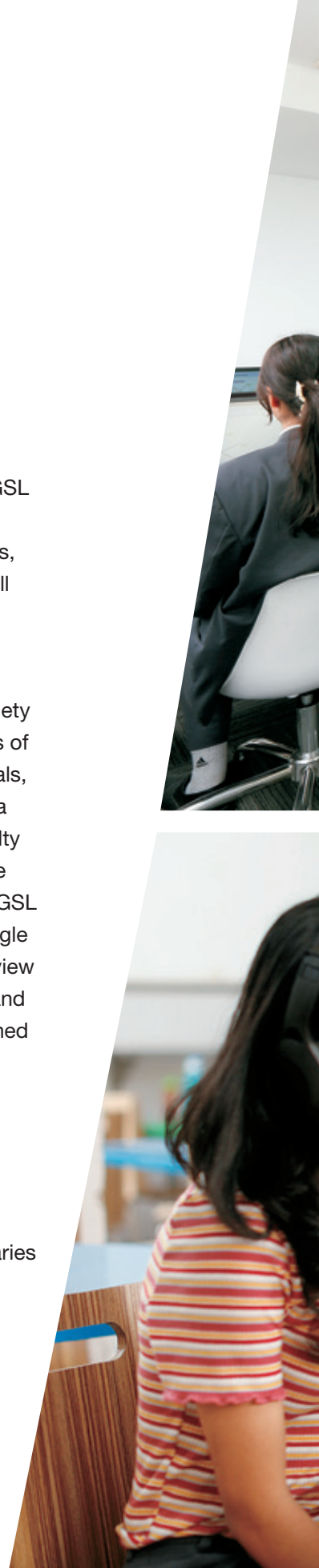


## LIBRARY

GSL has a very standard library. It is installed to catering the learning needs of the practitioners and learner communities associated to the College. The library at GSL is a continually updated resource center and it stalks several volumes of magazines, journals, encyclopedias, references as well as textbooks relating to different subjects relevant to law and other disciplines.

In addition, the GSL library contains a variety of audiovisuals, digital and online versions of reference books, scientific research journals, and other learning materials arranged on a large scale. It makes possible for the faculty and students to engage in self-study while using the library in an unlimited way. The GSL library is adequately spacious where a single class can sit and at a time engage in a review of the secondary data-based references and books when doing their projects as assigned by the respective subject faculty.

The library at GSL is operated full-time and attended by the librarians deputed to keep its services active for over 12 hours on all working days a week. GSL library is networked with global and national e-libraries too.







## COMPUTER LAB

GSL has in place a high-tech supported modern computer lab where branded LCD computers are installed and availed with unlimited internet facility. The lab is equipped with a sufficient number of modern computers availed at the ratio of one computer for one student. Students are encouraged to use computers for academic and other technological work required to complete projects, research and other assignments for student learning in diverse subjects of law.



## CAFETERIA

GSL has in place an in-house cafeteria that offers healthy meals and snacks to its faculty, students, and staff at a very reasonable cost. The cafeteria is managed by hospitality professionals deputed to serving the visitors with fresh meals, breakfast and snacks over all the working and weekdays. ## MOOT-COURT PRACTICES

The moot court at Global School of Law is an essential component of the practical training for BALLB students, designed to simulate real court sessions and provide hands-on legal experience. Students participate in various stages of courtroom procedures, including drafting legal documents, presenting arguments and cross-examining witnesses in a simulated legal environment. These sessions enhance students' advocacy skills, legal research capabilities, and understanding of courtroom etiquette while fostering critical thinking and public speaking confidence. The program prepares aspiring lawyers for real-world litigation and judicial processes, bridging the gap between theoretical knowledge and practical application.

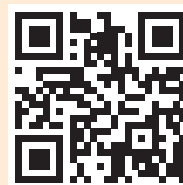
